Speaker	Misty Hanson (Wayne County Juvenile Court) discussed how the court handles juvenile cases and shared youth substance use statistics from the court	<ul style="list-style-type: none"> A thirty-minute screening for substance use, mental health, and trauma is done prior to deposition which is similar to a sentencing hearing. This screening is done for youth who either have no record, are not on probation, or have not had contact with the court in six months. A father's history or substance use has more of an influence on teen use than a mother's history of substance use. Hannah Gee described the SSI-SA substance misuse screening tool that is used when there is youth substance use. Most of the youth are using marijuana and alcohol. The court refers youth for further assessment or drug education depending on substance use risk factors. The court has positive influence programs through Catholic Charities, mentorship programs, after-school activities, etc. The court will refer youth to OneEighty and similar organizations for treatment if necessary. 	<ul style="list-style-type: none"> 50-60% of juveniles self-report substance use during screenings Numbers were lower during COVID, but the theory is that there was less self-reporting due to no school and a lack of supervision. 75% of youth self-reporting are at low risk for substance misuse. Staff will send out Misty's PowerPoint presentation with more statistics with the meeting minutes.
