Speaker	Amanda Nickles, Youth Mentoring & Prevention Specialist at OneEighty	 The goal of Amanda's position is to design and implement youth mentoring programs and guide youth-led prevention aimed at reducing abuse among youth and promoting wellness so youth can thrive. Amanda currently works with youth in four schools, and these youth are recommended to her based on present risk factors such as demonstrating risky behaviors or parental history of substance misuse or incarceration. Amanda briefly reviewed the LifeSkills curriculum she uses when meeting with students. Amanda reviewed Search Institute's 40 Developmental Assets for Middle Childhood (Ages 8-12) which include support, empowerment, positive values, and positive identity amongst others. Amanda is currently doing research focused on the differences between prevention and intervention to prepare for further conversations with schools and youth-serving organizations on how to best help all students. Laura and Amanda led a group discussion on the similarities and differences between the services Goodwill and OneEighty provide to students, along with the challenges that they face. There was a group discussion on additional ways to provide support to students beyond OneEighty and Goodwill. 	 Schools recommend students to Amanda, and parents must sign permission slips for students to meet with her. Amanda has met with 19 students so far this year, and currently has 18 students on her caseload. LifeSkills curriculum covers self-esteem, decision making, communication and effective communication, anxiety, making and managing friendships, speaking up for yourself, learning to say "no", understanding and resisting marketing pressures and resisting drugs or substance use. Goodwill focuses on education and employment goals, but the students Goodwill and OneEighty serve face similar situations. Some of the challenges the programs face in meeting with students are time, space, and privacy.
